Report of the Governing Body

NATURE, OBJECTIVES AND STRATEGIES:

The members present their report and the audited financial statements for the year ended 31 July 2025.

LEGAL STATUS

Xaverian College is a Roman Catholic College founded in 1862 by the Congregation of St Francis Xavier who were the Trustees until December 2001. From December 2001 the Trustees are the Roman Catholic Diocese of Salford.

Xaverian College was designated into the Further Education Sector under the terms of the Further and Higher Education Act 1992 on the 1st April 1993 and became a further education corporation under the terms of the Education (Designated Sixth Form Colleges) (Incorporation) (England) Order 2001.

From November 2022, and following a review by the Office for National Statistics, the College returned to the Public Sector Classification and must abide by the Managing Public Money guidance.

The College is an exempt charity for the purposes of Part 3 of the Charities Act 2011.

MISSION

The Governors review the College's Mission each year and have agreed that the statement is still relevant in today's world and that it is appropriate for it to continue as the College's Mission.

In delivering its mission, the College provides the following identifiable public benefits through the advancement of education:

- To provide the opportunity for young people to experience the values and way of life of a Catholic community.
- To enable young people to realise their full potential.
- To nurture the spiritual, moral and personal development of young people.
- To positively contribute to local and national developments.

PUBLIC BENEFIT

Xaverian College is an exempt charity under Part 3 of the Charities Act 2011 and from 1st September 2013 is regulated by the Secretary of State for Education. The members of the Governing Body are disclosed on pages 14-15.

In setting and reviewing the College's strategic objectives, the Governing Body has had due regard for the Charity Commission's guidance on public benefit and particularly upon its supplementary guidance on the advancement of education. The guidance sets out the requirement that all organisations wishing to be recognised as charities must demonstrate, explicitly, that their aims are for the public benefit.

The details pertaining to the delivery of public benefit are covered throughout the Members Report.

Each year the College reviews its 3-year strategic plan. This strategic plan includes property and financial plans and ensures that the student is at the centre of our plans. The Governing Body monitors the performance of the College against these plans. The College's continuing strategic objectives and targets are:

- **To nurture and celebrate the distinctive Catholic nature of the college**
 - Support and nurture the liturgical and prayer life of the College and encourage all members of the community to participate in these activities.
 - Provide opportunities that encourage all members of the community to contribute to the College's mission and ethos.
 - Provide a high level of resource to support the RE team and chaplaincy.
- **To provide a range of programmes responsive to the needs and interest of the individual and Manchester**
 - Provide an attractive, inclusive, and appropriate curriculum.
 - Ensure coherent curriculum planning.
 - Ensure learners develop personal, social and employability skills.
- **To deliver outstanding provision**
 - Provide the highest standards of teaching, learning and assessment.
 - Ensure quality improvement, standards and processes deliver outstanding teaching, learning and assessment.
 - Ensure all learners achieve and make progress relative to their starting points and learning goals.
- **To support young people to overcome the challenges they face on both a personal and academic level**
 - Provide outstanding guidance that meets the individual needs of students.
 - Support and develop students as independent learners.
 - Ensure that support for students enables them to fulfil their potential.
- **To provide outstanding leadership**
 - Ensure the college is in a strong strategic position.
 - Ensure the college workforce is suitably qualified and well trained.
 - Provide high quality accommodation and resources.
 - Provide excellent financial management and value for money.

The College is on target to achieve these objectives.

FINANCIAL OBJECTIVES

The College's financial objectives were to:

- provide management accounts within 10 working days of each period end;
- maintain the Financial Health Grade as at least 'Good';
- maintain at least 90 cash days;
- maintain a current ratio of at least 3:1;
- pay suppliers within 30 days of receipt of a valid invoice;
- continue to make all funding body financial returns on time;
- continue to make all funding body non-financial returns on time; and
- continue to ensure all financial statement audit reports are unqualified.

All of the above objectives were achieved in 2024/25 and the objectives have been adopted, once more, for 2025/26 onwards.

A series of performance indicators have been agreed to monitor the successful implementation of the policies.

The Colleges' 2-year financial forecast for 2025 to 2027, prepared in June 2025 under the new SORP and in the form of the Integrated Financial Model, shows the college's financial health as being 'Outstanding' for each of 2024/25, 2025/26 and 2026/27. This assessment is the same under the proposed, new financial health calculations.

Performance indicators

The College is committed to observing the importance of sector measures and indicators, using benchmarks provided by the Sixth Form Colleges Association, the Joint Council for Qualifications and the UCAS status report.

Key performance indicators include:-

- Pass Rates
- Retention
- Achievement
- High Grades
- Value Added
- Destinations

The College is required to complete the annual Integrated Financial Model for the Department for Education (DfE). The finance model produces a financial health grading. The current rating of Outstanding is considered an acceptable outcome.

Reserves policy

As part of the financial scrutiny provided by the Governing Body, the reserves are reviewed in conjunction with treasury policy. The review ensures that the level of reserves are aligned to the strategy of the College. The reserves will be utilised in line with the College strategy to ensure the best learning environment is created and maintained for the students.

FINANCIAL POSITION**Financial results**

The College delivered an operating surplus in the year of £1,831,222 (2023/24 surplus £1,675,622). Excluding the effects of the Local Government Pension Scheme & Enhanced Pension Provision costs, the College delivered an underlying surplus of £1,609,831 in year (2023/24 surplus £1,519,337).

The College has accumulated reserves of £22,994,132 at 31 July 2025 (2023/24 £21,302,921) and cash balances of £4,716,155 (2023/24 £6,852,593) at 31 July 2025.

In 2024/25 the College completed the building of a new Science Block which is necessary to support the growing demand for science subjects in the Greater Manchester area. The building was part-funded by the Government through a capital grant of £4m with the College contributing the remaining £3.5m from its reserves. The building was delivered on time and on budget and will be open to students for the 2025/26 academic year.

In 2024/25 the College had to invest in additional, temporary accommodation to cope with the increasing demographics of 16-19 students in Greater Manchester. Further, fixed, estate expansion will be required to enable the College to remove this temporary accommodation in the medium term and to allow the College to support the growth in the 16-19 cohort across the city.

The College has significant reliance on the education sector funding bodies for its principal funding source, largely from recurrent grants. In 2024/25 the funding bodies provided 94.4% (2023/24 93.6%) of the College's total income, excluding the release of Capital Grants.

Tangible fixed asset additions during the year amounted to £7,200,360 of which £6,531,153 related to the works on the new Science Block and Maryland roof replacement at the College.

TREASURY POLICIES AND OBJECTIVES

Treasury management is the management of the College's cash flows, its banking, money market and capital market transactions; the effective control of the risks associated with those activities; and the pursuit of optimum performance consistent with those risks.

The College has a separate treasury management policy in place.

Under the guidance of Managing Public Money the College is now unable to take new commercial loans but this is not seen as a priority or need in the foreseeable future.

CASH FLOWS AND LIQUIDITY

There was a net cash outflow of £2,136,438 in 2024/25 (2023/24 inflow of £636,716). The outflow being due to the investment in the new Science Block.

The size of the College's total borrowing and its approach to interest rates has been calculated to ensure a reasonable cushion between the total cost of servicing debt and operating cashflow. In 2024/25 the College repaid one of the two commercial loans it had outstanding at the end of 23/24.

The level of cash reserves held by the College is reviewed on a monthly basis with the target of maintaining cash days at or above the sector average. This has been comfortably achieved in 2024/25. The cash reserves have decreased year on year driven by the capital works in 2024/25. The reserves will increase through 2025/26.

CURRENT AND FUTURE DEVELOPMENT AND PERFORMANCE**Student numbers**

In 2024/25 the College enrolled 3,014 students (2023/24 3,026) and also provided teaching for 204 (2023/24 208) University of Manchester students studying their foundation year in BioSciences, Pre Dentistry, Pre Medicine or Pharmacy. In 2024/25 the student population was such that the College delivered core programme activity to a value of £17.142m under the new funding methodology. The University students funding being £766k in 2024/25 (2023/24 £790k).

Student achievements

At A Level, the College achieved a 98.6% pass rate, which is higher than 2024 (98.1%) and higher than this year's national pass rate of 97.5%. The percentage of students achieving high grades (A* - B) this year is 58.2% which is a significant improvement when compared with 51.5% in 2024. Level 3 BTEC was equally successful with an overall pass rate of 99.4% and high-grade achievement (Distinction*/Distinction) at 91.0%.

At GCSE, the overall pass rate is 65.2%, similar to the College pass rate of 65% in 2024 but significantly higher than this year's national pass rate for post-16 re-sits of 28.6%. The Level 2 BTEC pass rate is 100% which is the same as in 2024.

Students on the Level 1 Foundation Programme study for a BTEC Introductory Diploma comprising units in Business and Health & Social Care. In addition, they follow complimentary courses in Literacy and Numeracy. For these young people, many of whom have not progressed well at school, this study programme is a great boost to their confidence, skill development and employability prospects. The Foundation Department teachers and support staff have yet again produced results with a 100% pass rate.

The overall retention on the University Foundation Programmes, 2024-25 was 98.5%.

91.1% (51 out of the 56 students completing the course) achieved the standard required for progression to the first year of a Biosciences degree at the University of Manchester.

90.5% (86 out of 95 students) achieved the standard required for progression to the first year of Medicine or Dentistry at the University of Manchester.

72% (36 out of 50 students completing the exams) achieved the standard required for progression to the first year of Pharmacy at the University of Manchester.

Estate developments

In 2023, the need for further growth was requested by the Local Authority and in June 2025 the new Science Block was completed. Work was also completed on the replacement of the Maryland roof. As part of the sustainability drive, the College invested in solar power for 3 of its buildings with completion of the project in August 2024.

Curriculum developments

The College received Outstanding (grade 1) in all published categories of the last Ofsted inspection (May 2023) in recognition of its outstanding support of students to achieve in a wide range of curriculum from level 1 to level 4.

A particular strength is in making students ready for the next stage in their lives. Students at the College are supported, not only in their academic studies but also, through the pastoral system which provides advice, help and support.

The mission and ethos of the College is to try and support the whole person and help each student become the best version of themselves that they can be.

Many of our students have low levels of prior educational achievement. The College has constantly developed provision to meet the needs of students and support them on to Higher Education, Apprenticeships or Employment.

The College has introduced a number of new initiatives, such as the High Achievers Programme (for Gifted and Talented students) and the Dentists, Medics and Vets Programme. Such initiatives help the students to achieve and successfully support student progress to Higher Education.

The College has a very successful partnership with the University of Manchester providing Foundation Year programmes in BioSciences, Medicine, Dentistry and Pharmacy. The College is also heavily involved with Manchester Catholic Education Partnership (MANCEP) and is leading on an innovative Catholic Leadership & Management Programme involving staff from five outstanding North West sixth form colleges.

Payment performance

The Late Payment of Commercial Debts (Interest) Act 1998, which came into force on 1 November 1998, requires Colleges, in the absence of agreement to the contrary, to make payments to suppliers within 30 days of either the provision of goods or services or the date on which the invoice was received. The target set by the Treasury for payment to suppliers within 30 days is 95 per cent. During the accounting period 1 August 2024 to 31 July 2025 the College paid 99.1% of its invoices (by value) within 30 days (2023/24 95.8%). The College incurred no interest charges in respect of late payment for this period.

Streamlined Energy and Carbon Reporting

The College is committed to reducing its carbon emissions and has taken the following measures to improve energy efficiency:

Solar panels are fitted to 3 of the College buildings generating clean electricity whilst windows in the listed buildings have been replaced or repaired to improve heat retention. The College is recording energy usage by building to determine the impact of these measures. Further measures are planned for 2025/26.

EVENTS AFTER THE END OF THE REPORTING PERIOD

There are no adjusting or non-adjusting events occurring after the end of the reporting period.

FUTURE PROSPECTS

The DfE have confirmed core programme funding to the College for 2025/26 of £17,143,634 for 3,014 students.

The local authority asked that the College prepare for increased numbers in the medium term. With this in mind the College added capacity with the Teresa Quinn building in January 2021, added additional canteen and social space, erected temporary classrooms and completed the new Science Building.

Over 6,500 applications were received for 2025/26 and the recruitment at the College through September 2025 shows a student body numbering over 3,200.

The demand for places within the Sixth Form sector in Manchester remains strong. The College is well placed to meet this increase by the continuation of its successful A level and Applied level 3 programmes and continued development and adaptation of its level 1 and 2 programmes to meet the demand of the students recruited. The College is also exploring the possibility of providing some of the new T Levels in the future.

The investment in the estate and infrastructure will provide both additional capacity, to ensure that growth in student numbers could be accommodated, and an improved estate, to ensure the best teaching and learning outcomes in both the short and medium term.

During the production of the financial model for submission to the DfE, the College extended the financial forecasts to develop a five-year financial plan. This document provided assurance that the “going concern” assumption is valid and that the College can meet its liabilities. A range of financial strategies are in place should the assumptions in the document, for example, surrounding the student population, not come to fruition.

The College Governors approved a financial plan in July 2025, which sets out the objectives through to 2027 and which includes the need to explore further capital works.

The College has various resources that it can deploy in pursuit of its strategic objectives.

Financial

The College has £22.994 million of net assets (including £0.58 million pension liability) and long term bank debt of £457k. In 2023/24 the College had net assets of £21.303 million (£0.67m of which was pension liability) and long term bank debt of £994k.

The Local Government Pension Scheme asset included on the balance sheet in prior years has been reduced to nil to reflect the results of an asset ceiling report prepared by the actuaries.

People

The College employs 256 people on average (expressed as the headcount), of whom 145 are teaching staff. This is a slight increase on the previous year (249 expressed as a headcount). The College will continue with a non-replacement of leavers policy to maintain control of payroll expenditure, however, the continued growth in student numbers has required additional staffing.

Reputation

The College has a good reputation locally and nationally. Maintaining a quality brand is essential for the College's success at attracting students and external relationships.

PRINCIPAL RISKS AND UNCERTAINTIES:

The College has undertaken further work during the year to develop and embed the system of internal control, including financial, operational and risk management which is designed to protect the College's assets and reputation.

Based on the strategic plan, the Risk Management Group undertakes a comprehensive review of the risks to which the College is exposed. They identify systems and procedures, including specific preventable actions which should mitigate any potential impact on the College. The internal controls are then implemented and the subsequent year's appraisal will review their effectiveness and progress against risk mitigation actions. In addition to the annual review, the Risk Management Group will also consider any risks which may arise as a result of a new area of work being undertaken by the College.

A risk register is maintained at the College level which is reviewed at least annually by the Audit Committee and more frequently where necessary. The risk register identifies the key risks, the likelihood of those risks occurring, their potential impact on the College and the actions being taken to reduce and mitigate the risks. Risks are prioritised using a consistent scoring system.

The College had a risk management review with internal audit in 2024/25. A Governance review by internal auditors was carried out in 2023/24 and an external Governance review was carried out in 2023/24.

Not all the risk factors are within the College's control but the College carried out Business Continuity training in 2024/25 to ensure the senior team are able to react to adversity affecting the business.

Government funding

The College has considerable reliance on continued government funding through the further education sector funding bodies. In 2024/25, 94.4% of the College's revenue was ultimately public funded and this level of requirement is expected to continue. There can be no assurance that government policy or practice will remain the same or that public funding will continue at the same levels or on the same terms.

The College is aware that the demand-led funding system which applies a series of factors such as guided learning hours and success rates to calculate an amount of funding to be received for each learner cannot be guaranteed.

This risk is mitigated in a number of ways:

- Funding is derived through a number of direct contractual arrangements;
- Acquiring alternative sources of funding;
- By ensuring the College is rigorous in delivering high quality education and training;
- Considerable focus and investment is placed on maintaining and managing key relationships with the various funding bodies;
- Ensuring the College is focused on those priority sectors which will continue to benefit from public funding;
- Investing in the infrastructure so that the College can continue to provide high quality teaching and learning;
- Increasing the student cohort in a managed way with a targeted increase of 136 students in 2025/26 and 75 per annum thereafter over the medium term;
- Monitoring payroll expenditure closely and seeking efficiencies;
- Ensuring Value for Money in procurement and work under Managing Public Money; and
- Regular and positive dialogue with the funding bodies.

Tuition fee policy

In line with the majority of other colleges, Xaverian College will, if necessary, review tuition fees in accordance with the rising fee assumptions. However, as the College is primarily for 16 to 18-year old full time students, this will have little impact on the growth strategy of the College.

Maintain adequate funding of pension liabilities

In line with other colleges, Xaverian College may be required to make adjustment to its pension contribution rate in order to ensure the pension liabilities are adequately serviced.

Recent estate works have included innovative solutions to allow for access to those buildings where appropriate;
- The admissions policy for all students is described in the College charter. Appeals against a decision not to offer a place are dealt with under the complaints policy;
- The College has made a significant investment in the appointment of specialist staff to support students with learning difficulties and/or disabilities. There are a number of specialist support staff who can provide a variety of support for learning. There is a continuing programme of staff development to ensure the provision of a high level of appropriate support for students who have learning difficulties and/or disabilities;
- The College has in place a Disability Equality Scheme and Action Plan aimed at actively promoting disability equality; and
- Counselling and welfare services are described in the College Student Handbook which is issued to students and includes the complaints and disciplinary procedure. The College now employs three counsellors, 2 of whom are full time employees offering assistance throughout holiday periods as well as during term time.

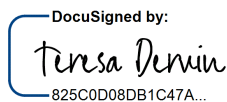
Going concern

It is the Governing Body's responsibility to bring independent judgement to bear on issues of strategy, performance, resources and standards of conduct.

The Governing Body is provided with regular and timely information on the overall financial performance of the College together with other information such as performance against funding targets, proposed capital expenditure, quality matters and personnel-related matters such as health and safety and environmental issues. The Governing Body met five times in 2024/25.

The Governing Body conducts its business through a number of committees. Each committee has terms of reference, which have been approved by the Governing Body. These committees are Finance, Personnel and Resources, Audit, Remuneration, Quality and Standards and Search. An Appeals Committee and Special Committee also meet when required. Full minutes of all Governing Body meetings, except those deemed to be confidential are available on the College's website (www.xaverian.ac.uk) or from the Clerk to the Governing Body at:

The Clerk to the Governors maintains a register of financial and personal interests of the Governors. The register is available for inspection on request to the Clerk to Governors at the above address.

All Governors and the Clerk to Governors are able to take independent professional advice in furtherance of their duties at the College's expense. All Governors have access to the Clerk to the Governors, who is responsible to the Governing Body for ensuring that all applicable procedures and regulations are complied with. The appointment, evaluation and removal of the Clerk are matters for the Governing Body as a whole.

Formal agendas, papers and reports are supplied to Governors in a timely manner, prior to the Governing Body meetings. Briefings are also provided as required.

The Governing Body has a strong and independent non-executive element, and no individual or group dominates its decision making process. The Governing Body considers that each of its non-executive members is independent of management and free from any business or other relationship which could materially interfere with the exercise of their independent judgement.

There is a clear division of responsibility in that the roles of the Chair and Principal are separate.

Appointments to the Governing Body

Any new appointments to the Governing Body are a matter for the consideration of the Governing Body as a whole. The Governing Body has a "Search" committee which is responsible for the recommendation of any new

member for the Governing Body's consideration. The Governing Body is responsible for ensuring that appropriate training is provided as required. Appointment of Foundation Governors is subject to approval by the Trustees.

Members of the Governing Body are appointed for a term of office not exceeding four years.

Governing Body performance

The Governing Body prepares a detailed Self-Assessment Report (SAR) which critically considers the effectiveness of key areas of Governance and highlights strengths and areas for development. The SAR is reviewed annually by the Committee Chairs and is presented to the Quality & Standards Committee in January and to the full Governing Body in February. The SAR is reviewed mid-year to check on progress of actions.

The Governing Body commissioned an External Review of Governance in 2024, which concluded with a final report in April 2024. The review was undertaken by Sandra Prail on behalf of the Association of Colleges. The overall conclusion on Board effectiveness was that "there is strong evidence that the Board is highly proficient and consistently impacts positively on college strategy, effectiveness and outcomes." Three recommendations were made for further improvement and the governors have agreed how these will be taken forward. A full copy of the external review is available on the college website.

The governors and clerk undertake a range of training and development, with presentations throughout the year and a Strategic Development Day with Senior Managers in the summer. Presentations this year included Student Destinations, Risk Management and Academisation. Governors also have access to a range of online learning, including Safeguarding.

Remuneration Committee

Throughout the year ended 31 July 2025, the College's Remuneration Committee comprised three Governors. The Committee's responsibilities include making recommendations to the Governing Body on the remuneration and benefits of the Principal, Director of Business and Finance, Vice Principal Student Support, Vice Principal Curriculum and the Clerk to the Governors, in accordance with the Governors' Policy on Remuneration. In setting the remuneration of Senior Postholders, the Remuneration Committee considers performance over the year, the Sixth Form Colleges Association averages for these roles and responsibilities and any financial restraints within the sector.

Details of remuneration for the year ended 31 July 2025 are set out in note 7 to the financial statements.

Audit Committee

The Audit Committee comprises five members of the Governing Body (excluding the Chair and Principal). The committee operates in accordance with written terms of reference approved by the Governing Body.

The Audit Committee meets on a termly basis and provides a forum for reporting by the College's internal, regularity and financial statements auditors, who have access to the Committee for independent discussion, without the presence of College management.

The College's internal auditors review the systems of internal control, risk management controls and governance processes in accordance with an agreed plan of input and report their findings to management and the Audit Committee.

Management is responsible for the implementation of agreed audit recommendations and internal audit undertake periodic follow up reviews to ensure such recommendations have been implemented.

The Audit Committee also advises the Governing Body on the appointment of internal, regularity, financial statements auditors and their remuneration for both audit and non-audit work as well as reporting to the Governing Body.

Internal control*Scope of responsibility*

The Governing Body is ultimately responsible for the College's system of internal control and for reviewing its effectiveness. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

The Governing Body has delegated the day-to-day responsibility to the Principal, as Accounting Officer, for maintaining a sound system of internal control that supports the achievement of the College's policies, aims and objectives, whilst safeguarding the public funds and assets for which he is personally responsible, in accordance with the responsibilities assigned to him in the Financial Agreement between Xaverian College and the funding bodies. He is also responsible for reporting to the Governing Body any material weaknesses or breakdowns in internal control.

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives; it can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an ongoing process designed to identify and prioritise the risks to the achievement of College policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in Xaverian College for the year ended 31 July 2025 and up to the date of approval of the annual report and accounts.

Capacity to handle risk

The Governing Body has reviewed the key risks to which the College is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The Governing Body is of the view that there is a formal ongoing process for identifying, evaluating and managing the College's significant risks that has been in place for the year ending 31 July 2025 and up to the date of approval of the annual report and accounts. This process is regularly reviewed by the Governing Body.

The risk and control framework

The system of internal control is based on a framework of regular management information, administrative procedures including the segregation of duties, and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting systems with an annual budget, which is reviewed and agreed by the governing body;
- regular reviews by the governing body of periodic and annual financial reports which indicate financial performance against forecasts;
- setting targets to measure financial and other performance;
- clearly defined capital investment control guidelines; and
- the adoption of formal project management disciplines, where appropriate.

Whilst internal audit is no longer a mandatory requirement, Xaverian College has made the decision to retain an internal audit service. The work of the internal audit service is informed by an analysis of the risks to which the college is exposed, and annual internal audit plans are based on this analysis. The analysis of risks and the internal audit plans are endorsed by the Governing Body on the recommendation of the audit committee. At minimum annually, Internal Auditors provide the governing body with a report on internal audit activity in the college. The report includes the Internal Auditor's independent opinion on the adequacy and effectiveness of the college's system of risk management, controls and governance processes.

Risks faced by the Corporation

The Corporation identifies, evaluates and manages risk through its governing body committee structure and the regular review and update of its risk register. The principal risks and uncertainties are set out in the strategic report.

Control weaknesses identified

No significant control weaknesses have been identified during the period.

Responsibilities under funding agreements

The Governing Body has met its contractual obligations under its funding agreements with the DfE through its work in its sub-committees, reports from management and reliance on the work of internal and external auditors.

The Department for Education and the Education and Skills Funding Agency introduced new controls for the College on 29th November, 2022 on the day that the Office for National Statistics reclassified Colleges as Public Sector Organisations in the national accounts. The DfE Chief Executive communicated these changes to all College Accounting Officers and introduced a new College Financial Handbook in 2024. The College has reviewed its policies, procedures and approval processes in line with these new requirements, to ensure there are systems in place to identify and handle any transactions for which DfE approval is required.

Statement from the audit committee

The audit committee has advised the Governing Body that the Corporation has an effective framework for governance and risk management in place. The specific areas of work undertaken by the internal auditors on behalf of the audit committee this year are Fixed Assets, Safeguarding, Health and Safety, Student Recruitment and Enrolment and Follow-Up.

As Accounting Officer, the Principal has responsibility for reviewing the effectiveness of the system of internal control. His review of the effectiveness of the system of internal control is informed by:

- comments made by the College's financial statements auditors and the regularity auditors in their management letters and other reports.

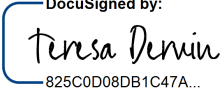
The Principal has been advised on the implications of the result of his review of the effectiveness of the system of internal control by the audit committee, which oversees the work of the internal auditor and other sources of assurance, and a plan to address weaknesses and ensure continuous improvement of the system is in place.

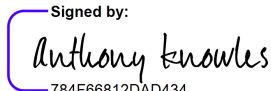
The senior management team receives reports setting out key performance and risk indicators and considers possible control issues brought to their attention by early warning mechanisms, which are embedded within the departments and reinforced by risk awareness training. The senior management team and the Audit Committee also receive regular reports from internal audit and other sources of assurance, which include recommendations for improvement. The Audit Committee's role in this area is confined to a high level review of the arrangements for internal control.

The Governing Body's agenda includes a regular item for consideration of risk and control and receives reports thereon from the senior management team and the Audit Committee. The emphasis is on obtaining the relevant degree of assurance and not merely reporting by exception. At its December 2025 meeting, the Governing Body carried out the annual assessment for the year ended 31 July 2025 by considering documentation from the senior management team and internal audit, and taking into account events since 31 July 2025.

Based on the advice of the Audit Committee and the Principal, the Governing Body is of the opinion that the College has an adequate and effective framework for governance, risk management and control, and has fulfilled its statutory responsibility for the effective and efficient use of resources, the solvency of the institution and the body and the safeguarding of their assets.

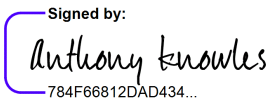

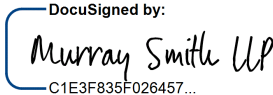

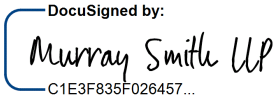

Notes to the Accounts

1. Statement of accounting policies and estimation techniques

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements.

Basis of preparation

These financial statements have been prepared in accordance with the *Statement of Recommended Practice: Accounting for Further and Higher Education 2019* (the 2019 FE HE SORP), the *College Accounts Direction for 2024 to 2025* and in accordance with Financial Reporting Standard 102 – “*The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland*” (FRS 102). The College is a public benefit entity and has therefore applied the relevant public benefit requirements of FRS 102.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the College's accounting policies.

Basis of accounting

The financial statements are prepared in accordance with the historical cost convention modified by the revaluation of certain fixed assets and in accordance with applicable Accounting Standards.

Going concern

The activities of the College, together with the factors likely to affect its future development and performance are set out in the Governing Body Report. The financial position of the College, its cashflow, liquidity and borrowings are presented in the Financial Statements and accompanying Notes.

The College currently has £457k of loans outstanding with the Royal Bank of Scotland. One loan has 6 years left to run whilst a second, smaller, loan was repaid in July 2025. The current cash reserves at the College, and the College's forecasts and financial projections, indicate that it will be able to service both loans for the foreseeable future.

Over the last few years, the College has seen steady growth in student numbers as a result of the changing demographic within the Greater Manchester area. Such growth has allowed the College to maintain its resources, invest in its estate and keep teaching and learning at the heart of its community.

Whilst some further growth is forecast, the College has a reasonable expectation that it has adequate resources to continue in operational existence for the foreseeable future. The College also has robust financial strategies should there be any further financial pressures. In 2020/21, an additional, 8 classroom, teaching block came on stream to support the growth in the 16-18 cohort in the Manchester area, in 2021/22, further capital expenditure provided additional canteen and social space. Both projects were funded from College reserves. In 2024/25 a new Science block was completed which replaced the old Sunbury building. The building cost was £7.5m with the College contributing £3.7m from reserves to date. In 2025/26 work will begin on the feasibility of replacing the Xavier building with a new multi-classroom building. Refurbishment of the Xavier building is prohibitively expensive and so demolition and replacement is the only option. Failure to carry out this replacement will have knock-on effects as the temporary accommodation will be nearing the end of its planning permission period. The new build will be subject to capital funding becoming available. To alleviate estates pressures further temporary classrooms were sited in February 2025.

For this reason Xaverian College will continue to adopt the going concern basis in the preparation of its Financial Statements.

Government revenue grants include funding body recurrent grants and other grants and are accounted for under the accrual model as permitted by FRS 102. Funding body recurrent grants are measured in line with best estimates for the period of what is receivable and depend on the particular income stream involved.

The final grant income is normally determined with the conclusion of the year end reconciliation process with the funding body following the year end, and the results of any funding audits. 16-18 learner-responsive funding is not normally subject to reconciliation and is therefore not subject to contract adjustments.

Non-recurrent grants from non-government sources are recognised in income when the College is entitled to the income and performance related conditions have been met.

Government capital grants are capitalised, held as deferred income and recognised in income over the expected useful life of the asset, under the accrual method as permitted by FRS 102. Other capital grants are recognised in income when the College is entitled to the funds subject to any performance related conditions being met.

Income from tuition fees is recognised in the period for which it is received and includes all fees payable by students or their sponsors, for example the University of Manchester.

Income from grants, contracts and other services rendered is included to the extent of the completion of the contract or service concerned.

All income from short-term deposits is credited to the income and expenditure account in the period in which it is earned.

Accounting for post-employment benefits

Retirement benefits to employees of the College are provided by the Teachers' Pension Scheme (TPS) and the Local Government Pension Scheme (LGPS). These are defined benefit schemes, which are externally funded and contracted out of the State Second Pension.

Contributions to the TPS are calculated so as to spread the cost of pensions over employees' working lives with the College in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by qualified actuaries on the basis of quinquennial valuations using a prospective benefit method.

As stated in Note 20, the TPS is a multi-employer scheme and the College is unable to identify its share of the underlying assets and liabilities of the scheme on a consistent and reasonable basis. The TPS is therefore treated as a defined contribution scheme and the contributions recognised as they are paid each year.

The assets of the LGPS (Greater Manchester Pension Fund – "GMPF") are measured using closing fair values. The contributions are determined by qualified actuaries on the basis of triennial valuations using a prospective benefit method.

LGPS liabilities are measured using the projected unit credit method and discounted at the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred.

Net interest on the net defined benefit liability/asset is also recognised in the Statement of Comprehensive Income and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in interest and other finance costs.

Actuarial gains and losses are recognised immediately in the financial statements.

Short term Employment benefits

Short term employment benefits such as salaries and compensated absences (holiday pay) are recognised as an expense in the year in which the employees render service to the College. Any unused benefits are accrued and measured as the additional amount the College expects to pay as a result of the unused entitlement. Holiday periods for key personnel have been aligned with the College's financial year.

Enhanced Pensions

The actual cost of any enhanced ongoing pension to a former member of staff is paid by the college annually. An estimate of the expected future cost of any enhancement to the ongoing pension of a former member of staff is charged in full to the College's income in the year that the member of staff retires. In subsequent years a charge is made to provisions in the balance sheet

Non-current Assets - Tangible fixed assets

Tangible fixed assets are held at deemed cost less accumulated depreciation and accumulated impairment losses. Certain items of fixed assets that had been revalued to fair value on or prior to the date of transition to the 2015 FE HE SORP, are measured on the basis of deemed cost, being the revalued amount at the date of that revaluation, being 1 August 2014.

Land and buildings

For a number of elements of the estate (eg the frame), the remaining life assigned by GVA Grimley Ltd was greater than the "normal" life assigned and, as such, a cap has been applied.

The buildings are depreciated on a straight line basis over their expected useful lives as follows:

- Frame – 50 years,
- Windows – maximum of 30 years,
- Roof – maximum of 50 years,
- Lift – maximum of 30 years.

Land is not depreciated as is considered to have an infinite useful life.

The College has a policy of depreciating major adaptations to buildings over the period of their useful economic life of between 20 and 50 years.

Where land and buildings are acquired with the aid of specific Government grants, they are capitalised and depreciated as above. The related grants are credited to a deferred income account within creditors, and are released to the income and expenditure account over the expected useful economic life of the related asset on a systematic basis consistent with the depreciation policy. The deferred income is allocated between creditors due within one year and those due after more than one year.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying amount of any fixed asset may not be recoverable.

On adoption of FRS 102, the College followed the transitional provision to retain the book value of land and buildings, which were revalued as at 1 August 2014, as deemed cost but not to adopt a policy of revaluations of these properties in the future.

Where the revaluation resulted in the carrying value increasing, this has been recognised in the revaluation reserve. An annual transfer between the Revaluation Reserve and Income and Expenditure Reserve is performed of the additional depreciation arising as a result of the revaluation gain.

Where the College enjoys the use of an asset which it does not own, and for which no rental or a nominal rental is paid, if practicable, a value is attributed to this benefit and capitalised.

Assets under construction

Assets under construction are accounted for at cost, based on the value of architects' certificates and other direct costs, incurred to 31 July. They are not depreciated until they are brought into use.

Subsequent Expenditure on existing fixed assets

Where significant expenditure is incurred on tangible fixed assets after initial purchase it is charged to income in the period it is incurred, unless it increases the future benefits to the College in which case it is capitalised and depreciated on the relevant basis.

Equipment

Equipment and computer hardware costing less than £250 and furniture, fixtures, fittings and vehicles costing less than £500 per individual item are written off to the income and expenditure account in the period of acquisition.

Inherited equipment was depreciated on a straight-line basis over its remaining useful economic life to the College of 5 years from the original date of acquisition. All inherited equipment is now fully depreciated.

All other equipment is depreciated over its useful economic life as follows:

Equipment & IT Infrastructure	5 years on a straight-line basis
Computer Equipment	3 years on a straight-line basis

Where equipment is acquired with the aid of specific grants, it is capitalised and depreciated in accordance with the above policy, with the related grant being credited to a deferred capital grant account and released to the income and expenditure account over the expected economic life of the related equipment.

The College charges a full year of depreciation in the year of purchase and none in the year of disposal.

Leased assets

Costs in respect of operating leases are charged on a straight-line basis over the lease term.

Cash and cash equivalents

Cash includes cash in hand and deposits repayable on demand.

Provisions and contingent liabilities

Provisions are recognised when:

- the College has a present legal or constructive obligation as a result of a past event;
- it is probable that a transfer of economic benefit will be required to settle the obligation; and
- a reliable estimate can be made of the amount of the obligation.

Where the effect of the time value of money is material, the amount expected to be required to settle the obligation is recognised at present value using a pre-tax discount rate. The unwinding of the discount is recognised as a finance cost in the statement of comprehensive income in the period it arises.

A contingent liability arises from a past event that gives the College a possible obligation whose existence will only be confirmed by the occurrence or otherwise of uncertain future events not wholly within the control of the College.

Contingent liabilities also arise in circumstances where a provision would otherwise be made but either it is not probable that an outflow of resources will be required or the amount of the obligation cannot be measured reliably.

Contingent liabilities are not recognised in the balance sheet but are disclosed in the notes to the financial statements.

Agency arrangements

The College acts as an agent in the collection and payment of Discretionary Support Funds. Related payments received from the funding bodies and subsequent disbursements to students are excluded from the Income and Expenditure account and are shown separately in Note 22, except for the 5 per cent of the grant received which is available to the College to cover administration costs relating to the grant. The College recognises Free Meals in Further Education income in the Income and Expenditure account as it is incurred, with any expenditure being matched by the income released. Any shortfall in bursary funding is made up using Free Meals in Further Education Income.

Financial liabilities

Financial liabilities are classified according to the substance of the financial instrument's contractual obligations, rather than the financial instrument's legal form.

All loans held by the College are classified as basic financial instruments in accordance with FRS 102. These instruments are initially recorded at the transaction price less any transaction costs (historical cost). FRS 102 requires that basic financial instruments are subsequently measured at amortised cost. Loans and investments that are payable or receivable within one year are not discounted.

Taxation

The College is considered to pass the test set out in Paragraph 1 Schedule 6 Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the College is potentially exempt from taxation in respect of income or capital gains received within categories covered by sections 478-488 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

Judgements in applying accounting policies and key sources of estimation uncertainty***Tangible fixed assets***

- Tangible fixed assets, are depreciated over their useful lives taking into account residual values, where appropriate. Residual value assessments consider issues such as future market conditions, the remaining life of the asset and projected disposal values. An assessment of the useful life of the assets was performed at the date of valuation, and the change in useful lives applied as at the date of transition being 1 August 2014.
- The land and buildings utilised by the College are owned by the Diocese of Salford. The College has unrestricted use of the land and buildings and, in the judgement of management, such an arrangement is unlikely to cease in the near future. In management's judgement the College has control over, and will receive the future economic benefits from, the land and buildings, and consequently the land & buildings are recognised as Fixed Assets in the College Balance Sheet.

Local Government Pension Scheme and Enhanced Pension Provision

- The present value of the Local Government Pension Scheme defined benefit asset / (liability) depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost (income) for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 20, will impact the carrying amount of the pension asset / (liability). The actuary has used a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2025 to value the pensions liability at 31 July 2025. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension asset or liability.

The actuaries have once again reported a pension surplus as at the year end. This year the College commissioned an additional report containing an asset ceiling calculation which concluded that the asset would not result in a reduction in the future pension contributions. Under FRS 102 a pension asset should only be recognised if it is expected to result in a refund or a reduction in future contributions. Whilst the asset ceiling calculation depends on a variety of assumptions and therefore contains inherent uncertainties, the College has decided to reduce the pension asset to nil to reflect the result.

- As with the Local Government Pension Scheme, the factors affecting the Enhanced Pension Provision are determined externally to the College. Any changes in in these assumptions, which are disclosed in note 15, will impact the carrying amount of the Enhanced Pension Provision.

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pensions Scheme Regulations 2014. These regulations apply to teachers in schools, colleges and other educational establishments. Membership is automatic for teachers and lecturers at eligible institutions. Teachers and lecturers are able to opt out of the TPS.

Valuation of the Teachers' Pension Scheme

The TPS is an unfunded scheme and members contribute on a 'pay as you go' basis – these contributions, along with those made by employers, are credited to the Exchequer under arrangements governed by the above Act. Retirement and other pension benefits are paid by public funds provided by Parliament.

Under the definitions set out in FRS 102 (28.11), the TPS is a multi-employer pension plan. The college is unable to identify its share of the underlying assets and liabilities of the plan.

Accordingly, the college has taken advantage of the exemption in FRS 102 and has accounted for its contributions to the scheme as if it were a defined-contribution plan. The college has set out above the information available on the plan and the implications for the college in terms of the anticipated contribution rates.

The valuation of the TPS is carried out in line with regulations made under the Public Service Pension Act 2013. Valuations credit the teachers' pension account with a real rate of return assuming funds are invested in notional investments that produce that real rate of return.

The latest actuarial review of the TPS was carried out as at 31 March 2020. The valuation report was published by the Department for Education (the Department) in October 2023. The valuation reported total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service at the effective date of £262 billion, and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £222 billion giving a notional past service deficit of £40 billion (compared to £22 billion in the 2016 valuation)

As a result of the valuation, new employer contribution rates rose from 23.68% to 28.68% from April 2024. A full copy of the valuation report and supporting documentation can be found on the Teacher's Pension Scheme website.

The employer's payment of pension costs to TPS in the period amounted to £2,051,553 (2023: £1,724,335)

FRS 102 (28)

The scheme available to support staff is the Greater Manchester Pension Fund (GMPF). The LGPS is a funded defined-benefit plan, with the assets held in separate funds administered by the Greater Manchester Pension Fund through Tameside Borough Council.

The agreed employer contribution rate was 19%. The agreed contribution rates for employees range from 5.5% to 9.9%, depending on salary.

Principal Actuarial Assumptions

The college distributes 16-19 discretionary and vulnerable bursaries and free meals in further education (FEFM) funds to students as an agent for DfE.

In the accounting period ended 31 July 2025, the college received a total of £656k and disbursed £569k from DfE 16-19 discretionary and vulnerable bursaries and FEFM funding after charging £28k for administration costs.

As at 31 July 2025, the cumulative unspent 16-19 discretionary and vulnerable bursary funds and FEFM funding is £288k, of which £81k relates to funds that are in scope to be returned to DfE in March 2026. Comparatives for the accounting period ended 31 July 2024 are £684k received from DfE, £609k disbursed to learners after charging £27k for administration costs, and total cumulative unspent funds of £265k, of which £49k was repaid to DfE.
